

Launch of Build Canada Homes

Overview

Build Canada Homes officially launched on **September 14, 2025**, with CEO **Ana Bailão** and alongside Housing and Infrastructure Minister **Gregor Robertson**. Prime Minister Carney highlighted BCH as a central part of the government's housing response, aimed at financing, building, and accelerating affordable homes nationwide. BCH is also tied to broader goals, including job creation, industry development, and innovation in construction methods.

BCH is positioned as a federally owned builder and financer, aiming to double the pace of housing construction. It will work with partners across government and the housing ecosystem to increase non-market housing supply, support sustainable building, and encourage innovative construction technologies.

While this represents a significant step in federal involvement, Ontario's affordability crisis remains acute. Municipal approvals do not always translate into homes, and many low-income and vulnerable tenants continue to face housing insecurity.



BCH's Immediate Priorities

- 1. Fight homelessness through transitional and supportive housing.
- 2. Expand deeply affordable and community housing.
- 3. Partner with the private sector to provide housing for the middle class.
- 4. Build a stronger Canadian housing industry using modern construction methods.

How BCH Will Work

BCH will become a standalone federal agency in the coming year, with three main functions:

- 1. **Build affordable homes:** Plan, manage, and deliver projects with partners.
- 2. **Finance affordable homes:** Provide low-cost, multi-year financing to help non-market and Indigenous housing providers expand.
- 3. **Catalyze the industry:** Support innovative construction methods like modular and prefabricated housing.

Key supports include:

- **Federal lands:** BCH has access to 88 federal sites (463 hectares) and may receive additional sites for large-scale housing projects.
- **Financial incentives:** Flexible, low-cost financing and multi-year support for projects that may otherwise face funding challenges.
- **Streamlined approvals:** BCH aims to reduce administrative barriers, acting as a "onestop shop" for approvals, financing, and land access.
- **Innovative, sustainable construction:** Support for factory-built housing, mass timber, and low-carbon technologies, potentially cutting timelines by 50% and costs by 20%.
- **Buy Canadian:** Projects using Canadian materials strengthen local supply chains and create jobs.



First Four BCH Investments

- 1. **Six federal land sites for factory-built homes:** 4,000 homes across Ottawa, Toronto, Winnipeg, Edmonton, Dartmouth, and Longueuil.
- 2. **Rental Protection Fund:** \$1.5B for community housing providers to acquire at-risk rental housing and preserve long-term affordability.
- 3. **\$1B** for social and transitional housing: Paired with provincial, municipal, and Indigenous partners to provide wraparound supports.
- 4. **Nunavut partnership:** 700 affordable units, 30% built offsite, using innovative construction methods.

ONPHA's Role: Clarity and Advocacy

ONPHA continues to:

- **Seek clarity for members:** We are monitoring BCH's policies, funding programs, and processes to ensure community housing providers understand how to access support.
- **Advocate for providers:** We are actively engaging with federal partners to ensure the needs of community housing providers are represented.
- **Listen to our members:** Feedback from providers informs our advocacy and helps us identify the key questions where guidance is needed.
