This past year, ONPHA remained focused on two key priorities: advancing our advocacy and supporting our members. Together, we've kept community housing front and centre, delivered results with governments, and strengthened tools and resources for housing providers across Ontario.

Since 2018, ONPHA and CHF Canada's 10-year housing plan, developed within the context of the National Housing Strategy (NHS), has guided our advocacy through challenges and economic uncertainty. Now, as the NHS evolves into Build Canada Homes, it's an important moment to reflect on our progress and the work still ahead. The dashboard on the next page provides a snapshot of that progress, showing where our housing plan advocacy has moved the needle.

Throughout this report, you'll also see highlights of the results we achieved with and for our members in 2024–2025, from new investments and policy wins to expanded supports. We also continued to focus on ONPHA's own financial sustainability and growth to remain a strong voice for Ontario's community housing sector.

As we enter this next chapter, ONPHA will continue our work by advancing our advocacy, supporting government policy development, and providing practical tools for housing providers, service managers, and sector partners.

ONPHA'S ADVOCACY WORKING FOR YOU

10-YEAR HOUSING PLAN: PROGRESS SNAPSHOT

In 2018, ONPHA and CHF Canada launched a <u>10-year housing plan</u> with four bold goals. This snapshot highlights our progress from government commitments to new investments, showing how ONPHA's advocacy is delivering results for housing providers, tenants, and communities across Ontario.

BUILD 69,000 AFFORDABLE RENTAL HOMES





- 100% of target committed.
- Federal government and municipalities across
 Ontario put forward ambitious targets for
 affordable housing construction. Targets have
 not been met but progress has been made.
 - Since 2018, the Federal government committed funding to approximately 45,000 affordable rental homes in Ontario and set the target of supporting the creation of 240,000 new units nation-wide.
 - Toronto is targeting approval of 47,500 new affordable rental units by 2030.
 - Province provided \$570M between 2020-2024 to assist 4,376 units.

CREATE 30,000 NEW SUPPORTIVE HOUSING UNITS





- Progress made; continued opportunity for government to reach the target. New programs and funds became available to support new transitional and supportive housing.
- Progress:
 - Approximately 2,400 units completed and a total of 4,275 with committed funding through the Rapid Housing Initiative.
 - 4,376 new units supported by provincial program (Indigenous Supportive Housing Program, Social Service Relief Fund).
- Recent introduction of more ambitious plans:
 - Build Canada Homes investing \$1B in transitional and supportive housing.
 - City of Toronto committed to approving 18,000 supportive units by 2030.

EXTEND LIFE OF 260,000 COMMUNITY-OWNED RENTAL HOMES





- 100% of target committed.
- Federal funding repaired 127,000 units;
- Ontario maintained 131,063 RGI subsidies;
- Federal government has committed \$231.88M to support 48,735 existing community housing units nationwide.

DELIVER INCOME SUPPORT TO 311,000 HOUSEHOLDS





- Maintained base; 20% of new target met.
- Ontario and CMHC set targets of 19,660 new rent assisted units and 43,604 households assisted through Canada Housing Benefit by 2028. Progress to date:
 - 15,932 Ontario households assisted through Canada Housing Benefit.
 - 2,414 new rent assisted units in Ontario
 - Approximately 304,700 households are supported through RGI in Ontario.



ADVOCACY THAT MEETS THE MOMENT

This past year, ONPHA formalized our <u>Build, Protect & Support</u> advocacy strategy, a framework designed to meet the evolving needs of Ontario's community housing sector. The strategy guides our efforts to ensure that housing providers, tenants, and communities are supported through key moments of change.

As hundreds of mortgages and operating agreements reached their end, we needed a strategy that would support the sector through negotiations and prepare for a sustainable future. Recognizing that our sector has the land and expertise to deliver more housing supply, we focused on securing federal and provincial acquisition funding, as well as no-cost solutions governments could implement immediately, streamlining processes and cutting red tape to support housing providers.

the power of ACQUISITION FUNDING

At ONPHA, we've long understood that we can't build our way out of the housing crisis fast enough. Instead, we need a multiple-strategy approach: grow new housing stock while also protecting what we already have. A dedicated acquisition fund is essential to making that happen. That's why it's central to our <u>Build</u>, <u>Protect & Support</u> strategy.

PARTNERING FOR IMPACT: CANADIAN HOUSING ACQUISITION FUND INC.

In 2024, the federal government announced the Canada Rental Protection Fund (CRPF), a landmark investment that marks a serious commitment to preserving affordability. Officially launched on March 7, 2025, the Fund will transfer at-risk rental housing into community ownership.



vote for housing ELECTION ADVOCACY

In 2024 we faced two critical elections. ONPHA was at the table engaging with all parties on both the provincial and federal sides to ensure our sector was at the centre of solutions no matter the election outcomes.

EQUIPPING THE SECTOR

ONPHA developed practical tools and resources, including:

- Election platforms and key messaging
- Templates to support member engagement with candidates
- Member updates and housing commitments trackers to keep the sector informed about campaign developments



OUR IMPACT

Our coordinated advocacy strengthened the sector's collective voice and delivered tangible wins. We built early relationships with new government staff and amplified our message in the media, raising public awareness of community housing's essential role in solving the housing crisis.

Over time, our sustained advocacy has helped mobilize more than \$23 billion* in housing commitments, a powerful demonstration of our long-term influence and the growing political will to invest in community housing.

KEY PROVINCIAL WINS

Secured a provincial commitment to establish community housing targets for service areas, one of ONPHA's key platform asks.

The new federal government's Build Canada Homes plan includes some of the cutting red tape measures ONPHA has advocated for, as well as additional investment for affordable housing.

data-driven decisions ONPHA AWARDED FEDERAL RESEARCH FUNDING

This year, ONPHA was selected as a recipient of the Government of Canada's National Housing Strategy Research and Planning Fund, administered by the Canada Mortgage and Housing Corporation (CMHC). With this support, and in partnership with StrategyCorp, we launched "Identifying Strategies to Optimize and Scale Community Housing Development", a project that will generate original research to fill critical gaps in housing data.

For years, housing providers and policymakers have struggled with incomplete information about community housing development. Through this new project, and the continued expansion of the Low-End of Market Housing Monitor, we're strengthening the sector's evidence base, improving understanding of Ontario's affordable rental market, and supporting more informed policy and investment decisions.

"We know that the best solutions for Ontario's housing challenges come from those doing the work on the ground. This research is a key step toward building a housing system that truly works for our communities."

THE CHALLENGE

Ontario's housing crisis is outpacing solutions. Families, seniors, and individuals wait years for affordable homes, while providers face complex approval processes, limited financing, and few scalable development pathways.

Without better data and clear strategies, progress will remain stalled.

OUR APPROACH

- Generate new data and insights to address knowledge gaps in community housing development.
- Analyze successful models that can be adapted and scaled across Ontario.
- Develop practical tools and policy recommendations to help providers deliver more homes, faster.
- Share research findings with the sector so providers have evidencebased strategies to guide their work.



9 Grants delivered to housing providers

A key highlight this year is the continued success of <u>ONPHA's STEP Program</u>, delivered with support from the Province. To date, the program has approved STEP Grant funding for nine housing providers across multiple service manager areas to support in their End of Mortgage (EOM) preparedness work.

As we approach the next wave of agreement expirations, interest in the program remains strong with 79 inquiries received so far. The application process remains open, and we look forward to supporting more providers in the months ahead.







INVESTING IN THE NEXT GENERATION OF HOUSING LEADERS

In the fall of 2024, ONPHA hosted our first ever Housing Day Challenge in celebration of National Housing Week. We invited university students and emerging housing professionals to develop creative solutions to Ontario's housing crisis.

Participants teamed up with experienced housing mentors, and the top teams presented their ideas to a panel of judges. The winning team proposed "Closing the Gaps in Funding Frameworks for Non-Profit Housing". They advocated for a provincial acquisition funding and financing tool designed to give non-profit housing providers greater capacity and incentive to acquire properties and expand affordable housing across the province.
